Dear parents / carers

As you may have heard, yesterday the government announced that all schools must close to the majority of pupils due to the Coronavirus. The information contained within this letter is based on the information currently available from the government. We expect further announcements imminently and will advise you of any further developments tomorrow.

As a consequence, Park Academy West London will close with effect from the end of the school day this Friday 20th March 2020 until further notice. We will keep our website updated with any information about the date of reopening. The academy will, however, remain open to provide care for the children of key workers and for vulnerable children, which includes those children who have a social worker or an Education Health Care Plan. For these children the school day will start and finish at exactly the same times as now. There will be no after school clubs,

If you work in any of the following jobs you are classified as a key worker:

- NHS staff
- Police
- Supermarket delivery drivers
- Supermarket staff
- Pharmacy staff
- Fire service
- Armed services
- Teachers and other school staff

If this applies to you and you want your child to be cared for at school please complete the attached form and ensure your child brings it with them on Monday morning when they attend school. They should arrive at the main school atrium for registration and give it to a member of staff. Students should arrive at 8:15 and no later than 8:25. Can you also ensure that your child brings with them a change of PE kit and / or trainers as we would like to include some daily exercise into the curriculum.

If your child is classed as a vulnerable child they can also continue to attend the academy.

For all other students whose parents are not classified as key workers school or are not vulnerable children, the academy is closed for the foreseeable future. During the period of closure, teachers will be setting appropriate work for all students. This can be accessed in the following way:

Work will be available on the academy website by clicking on the tab in the top right hand corner entitled 'Year Group Revision'.

Students can contact their teacher via email for advice about their work during normal school hours. Students have been issued with these contact details.

Our expectations of students are that they should complete all of the work set by their teachers and should aim to work from home during normal school hours.

If your child receives Free School Meals these will still be available in the form of a packed lunch. These can be collected from reception every day at 1130am.

Even during a period of school closure, our primary concern is the safety of our pupils. We have identified Mrs Harris as a trained member of staff who has been designated to maintain regular contact with families where there are specific pupil needs. The contact details are: gharris@park-aspirations.org

During the closure that is an emergency email address or text number that parents can use to contact the school. It is important that this contact is only used for emergency messages and urgent queries and not for day to day contact with teachers. This address will be monitored daily by staff from the academy. The email address is info@park-aspirations.org and the contact number is the normal school number.

In England and in Wales, all exams in May and June have been cancelled, including GCSEs and A-levels as well as England's primary school national curriculum tests, known as Sats. As soon as we are informed by the government we will write to parents to explain how student grades will be awarded this year. The Government has already provided reassurances that students can expect to be awarded GCSE and A-level grades this summer and we are expecting that this will be through a combination of teachers' assessments, students' previous work and perhaps further sources of evidence. We expect to be able to update you about this soon.

Whilst my immediate concern is the health and safety of pupils and their families, clearly the longer-term impact is a concern too. Whilst it is too early to give a definitive answer on this, we are confident that government is currently exploring all possible scenarios and options and we will continue to be involved in these discussions.
